
Who's your Hero?

Covid-19: Keeping safe

Following the Governments lifting of Covid-19 restrictions during the Summer, and concerns over Winter, we continue to take a cautious approach to living with Coronavirus, ensuring that we prioritise the health and wellbeing of our staff and residents. To achieve this, we continue to operate with some of the Covid-19 secure arrangements which have been in place since the pandemic began.

Our staff will continue to wear face coverings and retain 2 metre social distancing. This approach has been taken to protect staff and residents and to reduce the likelihood of an employee needing to self-isolate as a result of a 'close contact'.

What does this mean within our schemes?

Communal lounges - All communal areas across our schemes re-opened on the 16 July 2021. We will continue to monitor any additional guidance from the Government related to the use of our communal areas, if necessary, we will inform you of any additional recommended measures.

Wearing of face coverings - we continue to promote the wearing of a face covering when accessing communal areas of our schemes in line with the advice given by the Government.

Repairs and maintenance work - we continue to work to Covid Secure arrangements, this includes both our in-house team and contractors being asked to wear face coverings whilst working in internal parts of our schemes.

Within our Housing with Extra Care schemes:

Restaurant - social distancing and/or the rule of 6 no longer applies when using our restaurant. However, we continue to operate both a table service and home delivery service for all residents. We ask that 2 metre social distancing is maintained with our staff, and we will continue to log 'Track and Trace' records. The wearing of face coverings by residents will be encouraged at all times when away from the dining table.

Social events - we will be taking a cautious approach to planned social events. Whilst Covid 19 cases are increasing we will limit events to those that have been valued and missed during the pandemic, such as bingo and coffee mornings. We will continue to operate these with Covid secure arrangements in place. LACE based meetings will be postponed until such time as the rate of Covid infection reduces. This is to protect both staff and residents in attendance.

Regular Covid 19 testing - we are asked to continue the regular testing of staff and residents working or living in our Housing with Extra Care Schemes.

Volunteering

We understand that during the Covid 19 pandemic, our volunteers around the schemes were missed by both staff and residents. As a voluntary organisation our volunteers are hugely important to us and our residents.

We wanted to find out a little bit more about what volunteering means to our volunteers and why they selflessly give up their time to support our residents and staff.

We spoke to Carol, who volunteers at Olsen Court and is a member of 'Friends of LACE Housing' who support various events such as open evenings, opening ceremonies, local fairs and community events. Carol is also a resident at one of our schemes.

"I have been an official volunteer for over 5 years now. I enjoy being able to provide friendship and support to residents and as a resident myself I can share my own experiences and 'sign post' others, should they need additional advice or support."

"One of the things I enjoy the most about volunteering is the camaraderie between residents and staff and being able to offer support and help to people".

"I believe that the qualities and personality traits, a volunteer should possess at LACE Housing is to be able to offer your time to support others, have a caring, friendly, and approachable nature with openness and empathy towards others".



We would like to thank all of our volunteers, who have supported us through a very difficult 18 months and we are delighted to be able to welcome many of you back into our schemes.

Time to check your heating!

As the season begins to change and the nights begin to draw in, now is a good time to see if your heating is in good working order before the colder weather arrives. By testing your heating now, you can identify any problems with your heating early, allowing our property maintenance team time to respond. If you need to report any faults you can do this by either visiting our website www.lacehousing.org or by calling 01522 514444 Monday to Friday, 9.00am to 1.00pm.

Do you know how your heating system functions? It's a good idea to get clued up on the basic instructions for your boiler to ensure you can stay warm throughout the cold weather. Keeping the heating on at a low constant temperature, rather than heating your home up rapidly and then allowing it to cool down again, will avoid any build-up of condensation, ensure your boiler is more energy efficient and could save you money!

Make sure your radiators or heaters are not obstructed by any pieces of furniture or curtains so the heat can flow evenly around your home.

In the unfortunate event that your heating stops working, we will always endeavor to respond as quickly as possible. However, please be aware that we may not be able to respond immediately or that the supply of parts can take longer. Therefore, it is a good idea to have a small electric heater to use as a back-up.

Work begins at Collinson Court

During the pandemic, we have continued to review new development opportunities ensuring we deliver much needed affordable housing across Greater Lincolnshire. We are extremely pleased to announce that work has begun on our latest development, Collinson Court, in Scunthorpe.

Local builders, TG Sowerby Developments, have been awarded the contract to build our supported living scheme, which sits on the former site of The Riddings Methodist Church.

Our new scheme incorporates 16 one and two bedroom apartments as well as a communal lounge/kitchen facility,

mobility scooter store and enclosed private gardens. The scheme is located within easy reach of convenience stores, supermarkets, takeaways, doctor's surgery and public transport.

Gordon and Maurice's Story

Gordon moved to our Housing with Extra Care scheme, Brick Kiln Place, 8 months ago, after living away from his family. However, he was not too far from his brother Maurice. Gordon's twin daughters, Esther and Jessica, both with on-going health issues, could no longer keep making regular journeys to visit Gordon and Maurice in Birmingham, both of whom had ever growing care needs. Gordon was diagnosed with Dementia and the twins felt they were unable to support their father as much as they would like.

Gordon moved to our Housing with Extra Care scheme, Brick Kiln Place and is now living closer to his daughters. The support Gordon has received from his daughters and the team at Brick Kiln Place has turned his life around full circle. Gordon is now the schemes resident 'newspaper boy' and often invites other residents for a drink, either outside or in the restaurant, to initialise his CAMEO Club that he is going to set up following the lifting of Covid-19 restrictions. The club's name stands for 'come and meet each other'.

Following Gordons move, Maurice began to feel lonely and isolated, living so far away from Gordon, so the family also applied for an apartment for him at Brick Kiln Place. Maurice moved in 4 months ago and, as the same as Gordon, he is very gregarious and can often be found in the evening sitting with a few other gentlemen, enjoying a pint on the balcony.

With the support of the twins, they have recently taken up horse riding, not just for exercise but to meet new people and try new things to keep them occupied.

Tracey Warren, Scheme Manager, Brick Kiln Place said "I cannot express enough how Housing with Extra Care, plus the support from their family, has changed both their lives, even during lockdown. They have both found ways to enjoy life with on-line music lessons, virtual meetings with family, distant coffee meet ups with residents... the list goes on. They have both told me tales about their lives and growing up"

"I think they are a true example of how life can still be good with the right support and care available, ensuring you can still live life to the full, at any age".



Resident Involvement Group



We always pride ourselves on working closely with our residents and we actively encourage feedback from anyone living within our schemes. In 2019 we introduced our strategy which detailed our plans for a resident involvement group. Our Resident Involvement Group (RIG) provides a real opportunity to develop tenant scrutiny and continuously improve our services, enabling us to offer Value for Money to our residents!

This year we have focused on the re-launch of our RIG meetings, encouraging new members to join the group and using a virtual meeting platform. Considering the number of residents living within our schemes, we were delighted with the response we received and in July we held our first virtual RIG meeting. We were joined by six resident members, representing Housing with Extra Care and Supported Living and have held a further meeting in August, where we were joined by our two Scheme Managers. Virtual meetings, whilst scary, encourage wide representation and are good for the environment.

To date the meetings have concentrated on embedding the foundations of our Terms of Reference, Code of Conduct and Resident Involvement Strategy in to the group and have lightly touched on the seven Regulatory Standards. However, additional items were also discussed outside of the set agenda, such as the easing of Covid-19 restrictions. These

discussions have opened up opportunities for healthy debate and have shown the different views of our members.

Our next RIG meeting is due to be held on the 24th November 2021.
